Shortlisted candidates shall be required to make payment of Rs. 85,000/- for 1st Semester at this stage through SBI Collect upto **05.00 P.M.** on **26.10.2020** and the charges on account of Amenities, Health and Sports Facility, Hostel Rent and Advance Mess Bill adjustable against actual bill have been suspended in light of COVID-19 & to avoid financial hardship and the same shall be charged when the students resume in the Campus. No Extension shall be granted for payment of fee.
