## OFFICE ORDER

In pursuance of the directions issued by the Chief Secretary to Government, Haryana vide instructions No 62/19/2020-6GS-1 dated 16.04.2021 and in pursuance with the guidelines issued by the Director-General Higher Education Department, Haryana vide Memo No. DHE-010019/5/2020-Coordination-DHE, Date, Panchkula, the 17.04.2021 under the heading SOP regarding Closure of Colleges/Universities keeping in view of the increase in number of COVID-19 cases, health and safety of DBRANLU family, Hon'ble Vice-Chancellor has directed to notify the following directions for implementation by all the students, faculty members, staff members upto 30.04.2021:

1. The University will remain closed for the students for offline mode of studies and examinations. No students will be allowed to reside in the Hostel, also.
2. All the Deans, Chairperson/Directors/Heads/In-charges of the Offices/Deputy Registrars/Assistant Registrars/Superintendents and above or equivalent have to attend their office on regular basis.
3. All the teaching assignments and examinations assignments should be continued in online mode as usual as per their time-table/date sheet.
4. All officials residing in containment zones shall continue to be exempted from coming to office till the containment zone is de-notified.
5. All officials who attend office shall strictly follow COVID appropriate behaviour including wearing of mask, physical distancing use of sanitizer and frequent hand washing with soap and water.
6. Crowding in lifts, staircases, corridors, common areas is to be strictly avoided. Visiting of one branch to other branch or elsewhere be also avoided.
7. Meetings, as far as possible, to be conducted through video conferencing.
8. If any official(s) is not feeling well then do not attend the office on particular day with the permission of concerned Dean/ Chairperson/ Director/ Head/ In-charge. In addition to above, any official or their family members have any symptoms of COVID may go for RTPCR test and keep themselves in isolation till the receipt of report with intimation to the officer.
9. Entry of outsiders/visitors in the campus is to be curtailed appropriately.
10. All the employees of the age of 45 years and above are advised to get themselves vaccinated.
11. All students, faculty and staff are further advised to be more vigilant and careful on the COVID pandemic situation and follow preventive measures w.r.t. Corona Virus (COVID-19) as per Government guidelines issued from time to time.
