These candidates are required to submit self-attested photocopy of SC/ BCA /BCB /ESM/PwBD /ESP Certificate duly issued by the Competent Authority of Haryana. Likewise, the Eligible Sports Persons (ESP) are required to submit self-attested photocopy of the Sports Gradation Certificate duly issued by the Competent Authority. ESM/DESM/DFF(s) are required to submit self-attested photocopy of the Valid Eligibility Certificate duly issued by the respective Zila Sainik Board. The certificates must have been issued within 06 months of submission of application form.

EWS certificate on prescribed performa should be valid for the year in which the candidates have applied for the post as per Govt. instructions issued vide no. 1222/12/2019-IGS-III dated 25.02.2019. The EWS certificate issued for jobs in central govt. will not be considered irrespective of income mentioned in certificate.
