**INVITING ONLINE APPLICATIONS FOR ADMISSION TO B.B.A. LL.B. (HONS.) PROGRAMME  
(ACADEMIC SESSION 2026-2027)**

All interested and eligible candidates are hereby informed that online applications are invited for admission to the B.B.A. LL.B. (Hons.) Programme at Dr. B.R. Ambedkar National Law University (DBRANLU), Sonapat, Haryana, for the Academic Session 2026-2027. Admissions shall be made on the basis of the valid score of the Common Law Admission Test (CLAT-2026) conducted by the Consortium of National Law Universities. **ELIGIBILITY CRITERIA:**

An applicant seeking admission to the B.B.A. LL.B. (Hons.) Programme must fulfil the following eligibility criteria as prescribed by the Consortium of National Law Universities for CLAT-2026:

1. There is no upper age limit for candidates appearing for the B.B.A. LL.B. (Hons.) Programme.
2. Candidates who have passed the Senior Secondary School/Intermediate (10+2) or an equivalent examination from a recognized Board with a minimum of:
  - i. Forty-Five percent (45%) of marks or its equivalent grade; or
  - ii. Forty percent (40%) of marks or its equivalent grade in case of candidates belonging to SC/ST/PwD categories.
3. Candidates who are appearing for the qualifying examination (Class 10+2) in March/April 2026 are also eligible to apply. However, they shall be required to produce evidence of having passed the qualifying examination at the time of admission, failing which they shall lose their right to be considered for admission.
4. Candidates from any stream (Science, Commerce, Arts/Humanities) are eligible to apply, provided they satisfy the above conditions.

## **GUIDELINES/INSTRUCTIONS FOR ADMISSION:**

1. Admission to the B.B.A. LL.B. (Hons.) Programme shall be made strictly on the basis of valid CLAT-2026 score.
2. Admission of any candidate is liable to be cancelled without further notice at any time during the programme, if it is found that the candidate has produced fake/forged certificates or documents, or has indulged in any act of misconduct/indiscipline/moral turpitude, or has concealed any relevant information at the time of seeking provisional admission. Such candidates shall also be liable to be prosecuted under the Law.
3. Any attempt by the candidate or anyone else on his/her behalf to influence or pressurize any Authorities/Admission Committee of the University, directly or indirectly, for out-of-rules admission, shall disqualify the candidate from admission. Such candidates shall also be liable to be prosecuted as per the provisions of Law.
4. Candidates applying under reserved categories shall have to produce valid certificates in support of their claim. For OBC (NCL Only)/EWS certificates to be produced for the current year i.e. 01.04.2026.
5. Seats are subject to change at the discretion of the Competent Authority.

## **Note:**

1. Candidates must ensure that they provide a valid and functional email ID and mobile number while filling out the application form, as all communications will be made via email/SMS only.
2. All related updates will be uploaded on the University website only. Candidates are therefore advised to visit the University website ([www.dbranlu.ac.in](http://www.dbranlu.ac.in)) regularly.
3. Applications that are incomplete or received without payment of application fee or do not satisfy all prescribed requirements shall be deemed ineligible and will not be considered further.
