The applications are invited from the interested and eligible candidate (who have applied for and appeared in the CLAT and passed 10+2 or an equivalent examination with a minimum of Forty five percent (45%) of marks or its equivalent in grade or Forty Percent (40%) of marks or equivalent in case of candidates belonging to SC/ST/PwD categories.) for the admission in B.A. LL.B. 5-Year integrated course against the vacant seats may directly apply to the University through google form link (<a href="https://forms.gle/M7tP5ZdyA37Dsrkm6">https://forms.gle/M7tP5ZdyA37Dsrkm6</a>) after depositing the non-refundable registration fee of Rs. 2,000/- (Rs. Two Thousand Only) through Q-fix Link (<a href="https://forms.eduqfix.com/drbrnational/add">https://forms.eduqfix.com/drbrnational/add</a>) and also available on university website under the student corner named as New Admission Fee Portal upto 16.07.2025. The admission will be made strictly on the basis of CLAT Rank based merit list.

#### **Guidelines/Instruction for Online Counselling:**

- After the application submission period concludes, a comprehensive merit list of all candidates who have applied for Online Counselling along with registration fee will be prepared based on their CLAT-2025 score (All India Rank). This merit list will be published on the University website and will be used for current seat allocations as well as for filling any future vacancies that may arise due to unfilled seats.
- 2. Provisional Admission offers will be made to candidates in order of merit within their respective categories and candidates have to pay the admission fee of ₹1,23,000/-through the university website as per schedule of receiving the admission offer. Failure to do so will result in cancellation of the admission offer, and the seat will be allotted to the next eligible candidate in the respective category. Please note that all admissions are provisional and subject to successful verification of documents & facts given in the candidate's application form.

# Note:- Any acknowledgement regarding "applied for" for any document/undertaking, shall not be considered with regard to any original document

- 3. The admission of any candidate is liable to be cancelled without giving any further notice forthwith or at any time during the period of the entire course of study, if it is found that the candidate has/had produced fake/forged certificate(s)/document(s) or indulged in any act of misconduct/indiscipline/moral turpitude or has/had concealed any other relevant information at the time of seeking provisional admission. Such a candidate is also liable to be prosecuted under the Law besides being debarred from appearing in any of the Entrance Test of the University in future
- 4. Only High School/10th Standard mark sheet certificate for proof of age and Intermediate/10+2 exam mark sheet/Grade sheet for ascertaining qualifying percentage of marks, shall be considered for B.A. LL.B (Hons.) Programme.
- 5. Any attempt by the candidate or anyone else on his/her behalf, to influence and or pressurize any Authorities/Admission Committee of University directly/indirectly for his/her out of rules admission, shall disqualify, the candidate from the admission. Such candidates shall also be liable to be prosecuted as per the provision of Law.
- 6. The provisional admission of the candidates for the said programme shall be subject to such rules and regulations as may be framed by the University from time to time.

#### Note:

- 1. Candidates must ensure that they provide a valid and functional email ID while filling out the counselling form, as all communications will be made via email only. Please note that queries related to unread or non-functional email IDs will not be entertained under any circumstances.
- 2. Category certificate of the candidate should be of current financial year as per government norms in case of Backward Class and EWS.
- 3. If any seat among these categories becomes vacant in the future, no fresh applications will be invited; instead, candidates from the merit list prepared from this registration/counselling process will be considered for allocation of seat.

- 4. Further, if a seat in any specific category remains vacant due to the non-availability of eligible candidates in that category, the seat will be converted to another category in accordance with the university's seat conversion policy.
- 5. If, any seats for categories not mentioned in the above seat table become vacant, then separate application forms shall be called with same condition as mentioned above.
