Important Instructions for Posts under Advertisement No.05/2025.

- 1. Official Website Caution: Candidates are strictly advised to refer only to the official website of Dr. B.R. Ambedkar National Law University, Rai, Sonepat (www.dbranlu.ac.in). Vigilance is required against fraudulent websites and job racketeers.
- **2. Verification of Eligibility:** Applicants must ensure they meet the minimum essential qualifications prescribed for each post before submitting their applications.
- **3. Separate Applications Required:** Candidates applying for more than one post must submit separate applications and application fees for each post.
- 4. Academic Details—CGPA Conversion:
 - a. Where academic scores are indicated in CGPA, candidates must provide the corresponding conversion formula from the competent authority awarding the CGPA, supported by documentary proof.
 - b. If both CGPA and absolute marks are provided along with the conversion formula, CGPA shall be used to compute the percentage.
 - c. If only CGPA is provided and no conversion formula is issued by the awarding authority, the percentage shall be derived by multiplying the CGPA by 9 (default multiplier on a scale of 10).
 - d. If the conversion formula is being provided by the issuing authority and the candidate fails to provide a conversion formula, the CGPA shall be considered equivalent to the lowest qualifying marks.
- **5. Merit Calculation Precision:** While computing merit points, rounding off shall not be allowed. Scores must be recorded up to three decimal places.
- **6. Integrated Programs:** For integrated degree programs, percentage marks of both constituent degrees (graduation and post-graduation) shall be treated as the percentage of the integrated program.
- 7. Lateral Entry Programs: For lateral entry degree programs, percentage marks awarded by the degree-granting university shall be deemed final.
- **8. Determination of Eligibility:** Candidate eligibility shall be determined based on qualifications acquired and communicated to the University by the last date of application submission. No documents will be considered thereafter.
- **9. Scrutiny and Score Disclosure:** Post scrutiny by the designated Committee, evaluated scores based on candidate-submitted data shall be shared. Any discrepancy must be reported within stipulated time period or as per subsequent instructions.
- **10. Category-wise Applications:** Candidates from Unreserved or Reserved categories (DSC/OSC/BCA/BCB/PwBD/EWS) must submit separate application forms for each post they wish to apply for.
- 11. Ph.D. Prior to July 11, 2009: Candidates who registered for Ph.D. prior to July 11, 2009 must submit a certificate issued by the authorised signatory of the concerned university confirming fulfilment of conditions as per Haryana Government norms (vide letter dated 11.11.2022), as per Annexure-I titled "For the candidates who registered for Ph.D. program prior to July 11, 2009."
- 12. Ph.D. On or After July 11, 2009: Candidates registered for Ph.D. on or after July 11, 2009 must submit a certificate from the authorised signatory of the concerned university verifying fulfilment of the UGC Regulations, 2009 (minimum standards and procedure for award of Ph.D. degree), in accordance with Haryana Government norms (vide letter dated 11.11.2022), as per Annexure-II titled "For the candidates who registered for Ph.D. program on or after July 11, 2009."
- 13. Degrees from Specific Universities: Candidates who have obtained their degrees from any of the following institutions—Singhania University (Rajasthan), EIILM University (Sikkim), Manav Bharti University (Himachal Pradesh), Vinayaka Mission University (Sikkim and Salem, Tamil Nadu), and Global Open University (Nagaland)—and intend to claim benefit of their degree must submit a certificate from the respective university. In addition, they must also furnish either Annexure-III titled "For the candidates who registered for Ph.D. Programme prior to



- July 11, 2009" or "For the candidates who registered for Ph.D. Programme on or after July 11, 2009" as applicable.
- **14. Relevance of Discipline:** The University reserves the right to determine the relevance, allied nature, or suitability of academic disciplines while scrutinizing applications.
- **15. Reserved Category Consideration in General Posts:** Reserved category candidates will be considered under the General category strictly in accordance with Government letters No. EC/2018/20179-389 dated 26.04.2018 and No. 12/1-2017 Ad(3) dated 04.06.2018.
- **16. Domicile Requirement for Reservation:** The benefit of reservation shall be extended only to candidates who are domiciled in Haryana. Such candidates must submit a self-attested copy of a valid reserved category certificate issued by the Competent Authority of the Haryana Government.
- 17. Backward Class Reservation Criteria: Backward Class candidates (Block 'A' or 'B') seeking reservation benefit must submit a self-attested copy of a certificate issued by the Competent Authority of Haryana Government. This certificate must not be older than six months from the closing date of applications and must affirm that the candidate is not covered under the creamy layer criteria, in accordance with the State Government instructions outlined in letter Nos. 1170-SW(1)-95 dated 07.06.1995; 213-SW(1)-2010 dated 31.08.2010; 22/22/2004 3GS-III dated 14.06.2016; 1282-SW(1) dated 28.08.2018; and 512-SW(1)2021 dated 01.12.2021, as per Annexure-IV titled "Backward Class Certificate (Block 'A' or 'B')."
- **18. Email ID Requirement:** Candidates must possess a valid and active personal email ID. Those without email ID should create a new email ID prior to submitting the application form.
- **19. Mobile Number Requirement:** A valid mobile number must be provided at the time of application. All SMS communications, if any, will be sent to this number. Requests for changes to the mobile number or email ID during the recruitment process will not be entertained.
- 20. Recognition of Educational Qualification: All educational qualifications must be obtained from institutions recognized by the Government of India/State Government or approved by the relevant regulatory bodies. Final results of all educational qualification must have been declared on or before the last date of application submission. Only the candidates who can provide documentary evidence that the result was declared on or before the cutoff date and that they have qualified shall be deemed eligible.
- 21. Validity of Distance Education Degrees: As per the Ministry of Human Resource Development Notification No. 44 dated 01.03.1995 and published in the Gazette of India dated 10.06.2015, degrees obtained through Open/Distance Education Mode must be recognized by the Distance Education Council, IGNOU (now Distance Education Bureau). Degrees not recognized during the period of study shall not be accepted for the purpose of educational qualification.
- **22. Finality of Category Declaration:** No request for change in the applicant's category shall be entertained after submission of the application form.
- 23. Shortlisting Criteria for Faculty Positions: Shortlisting for interviews for the posts of Assistant Professor, Associate Professor, and Professor shall be based on the Academic and Research Score, calculated in accordance with Annexure 'C' for Assistant Professor and Annexure 'B' for Associate Professor and Professor. The number of candidates to be shortlisted will be determined by the University as per its discretion.
- **24. Publication of Shortlisted Candidates:** The list of shortlisted candidates will be published on the official website of Dr. B.R. Ambedkar National Law University, Rai, Sonepat. Any disputes relating to screening of applications shall be resolved solely as per the University's decision, which shall be final and binding.
- **25.** Travel and Lodging Expenses: No Travel Allowance (TA) or Daily Allowance (DA) shall be paid by the University for attending the selection process in person.
- 26. Forwarding of Application through Proper Channel: Applicants currently employed in government or public sector organizations must apply through proper channel and submit a No



Objection Certificate (NOC) signed by the authorized official of their employer, as per **Annexure-V**. Failure to apply through the proper channel shall result in non-consideration of past employment benefits, if selected.

27. Submission of Research Publications: For calculation of the research score:

Candidates must attach the **first page** of each publication along with valid proof that the journal is **peer-reviewed** or **UGC-listed**.

Candidates applying for the post of Professor and Associate Professor must necessarily attach **Best Ten** and **Best Seven** full-length research papers, respectively.

Original publications must be produced at the time of interview.

- **28. Supporting Documents to claim Research Score:** Candidates must attach documentary evidence for all claims related to publication status (e.g., peer-reviewed, impact factor, authorship, etc.). In the absence of such documents, no points shall be awarded. The Scrutiny Committee will award marks solely based on documents submitted with the application. No supplementary requests or claims shall be entertained during or after the selection process.
- **29. Applicant's Responsibility for Accuracy:** The responsibility for the accuracy, completeness, and authenticity of the information provided in the application form and supporting documents lies entirely with the applicant, both in terms of eligibility and selection. Applicants must refrain from furnishing false, tampered, or fabricated information and must not suppress any material facts while submitting the application.
- **30.** Conditional Nature of Candidature: Mere submission of an application or participation in any stage of the process shall not imply eligibility. Eligibility shall be verified against original documents at the time of selection. If any information is found to be false or misleading at any stage, the candidature shall be cancelled and the applicant shall be liable for legal action.
- **31. Responsibility for Errors and Misrepresentation:** The University shall not be held liable for any errors, omissions, or suppression of facts by the applicant—whether intentional or unintentional. Candidates must ensure they meet all eligibility criteria by the closing date for receipt of applications. Any deviation detected before or after selection will lead to cancellation of candidature and termination of service, along with legal consequences.
- **32. Action on Fraudulent Credentials:** If any applicant is screened, shortlisted, selected, or appointed based on credentials that are later found to be forged, fabricated, falsified, or inadmissible, their candidature or employment shall be terminated forthwith. The University reserves the right to verify all documents and antecedents during the course of service. If any submitted document is found to be fake or if material facts were intentionally concealed, the individual's services will be terminated and appropriate legal action shall be initiated.
- **33. Rectification of Errors in Selection Process:** In case of any inadvertent error or irregularity identified during any stage of the selection process, including after the issuance of the appointment letter, the University reserves the right to amend, withdraw, or cancel any communication made to the candidate. The decision of the University in such matters shall be final and binding.
- **34.** Canvassing: Any attempt to influence the recruitment process through canvassing shall lead to disqualification of the candidature.
- **35. Non-Filling of Advertised Posts:** The University reserves the right not to fill any advertised vacancy without assigning any reason.

Applications that are incomplete or submitted without the prescribed application fee shall be summarily rejected at the initial scrutiny stage without any further correspondence.
- **40. Legal Jurisdiction:** All disputes related to the recruitment shall exclusively fall under the jurisdiction of the courts situated in Sonepat, Haryana.
