General Terms & Conditions:

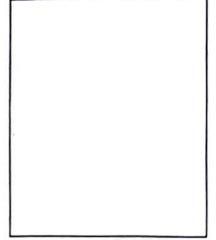
1. The appointment is for an initial period of **Three months** from the date of joining, and the term may be extended upon satisfactory performance with the approval of the Competent Authority.
