**FEE NOTICE FOR NEW ADMISSION (PG & UG): ACADEMIC SESSION 2026-27 (CLAT-26)**

This is for information of all the candidates who have been allotted a seat in this University through the CLAT–2026 Counselling process and selected the “Freeze” option in the 1<sup>st</sup>, 2<sup>nd</sup> or 3<sup>rd</sup> Round of Counselling are required to pay the remaining University Fee (after adjusting the Counselling Registration Fee and Confirmation Fee already paid) on or before **24<sup>th</sup> April 2026**.

Further, candidates who select the “Freeze” option in the 4<sup>th</sup> or 5<sup>th</sup> (Final) Round of Counselling shall be required to pay the remaining University Fee on or before **30<sup>th</sup> May 2026**.
