General Terms & Conditions/Instructions:

- 1. Admissions against aforementioned seats are now open to all candidates, regardless of whether they have previously applied. Candidates who have already submitted an application must reapply. Reserved category candidates are also eligible to apply; however, seat allotment will be based solely on the All India CLAT PG 2025 Rank *In the event that sufficient number of candidates with a valid CLAT PG 2025 score do not report for spot counselling, the remaining vacant seats shall be offered to candidates possessing a qualifying degree for admission to the LL.M. (One Year) programme. In such cases, merit shall be determined based on the percentage of marks obtained in the qualifying degree examination.
- 2. The University reserves the right to maintain waiting list to fill any future vacant seats, if any.
- 3. The willing candidates have to pay the application fee i.e. ₹2,500 (non-refundable) to be paid online.
- 4. Merit list will be prepared on the basis of the CLAT PG 2025 score (All India Rank) for all candidates who fulfil the eligibility conditions and pay the requisite registration/application fee.
- 5. Admission will be provisional and subject to the verification of all the documents and information/facts given in the candidate's application form.
- 6. Provisionally admitted candidates shall be required to deposit the full admission fee of ₹1,23,000/- (Rupees One Lakh Twenty-Three Thousand only) through online mode within the stipulated timeframe. Failure to deposit the fee shall result in cancellation of
