**Eligibility:** An LL.B. Degree or an equivalent examination with minimum of Fifty percent (50%) marks or its equivalent grade in case of candidates belonging to General/OBC/PWD categories and Forty-Five percent (45%) marks or its equivalent grade in case of candidates belonging to SC/ST categories. Candidates appearing for their qualifying examination are also eligible to apply.

**For Working Professionals:** Law Graduates with at least three (03) years of experience in government (Central/State), PSUs, industry, research, law firms, companies, advocacy, etc. are eligible to apply
