General Terms & Conditions/Instructions:

- 1. Admissions against aforementioned seats are now open to all candidates, regardless of whether they have previously applied. Candidates who have already submitted an application must reapply. Reserved category candidates are also eligible to apply; however, seat allotment will be based solely on the All India CLAT PG 2025 Rank *In the event that sufficient number of candidates with a valid CLAT PG 2025 score do not report for spot counselling, the remaining vacant seats shall be offered to candidates possessing a qualifying degree for admission to the LL.M. (One Year) programme. In such cases, merit shall be determined based on the percentage of marks obtained in the qualifying degree examination.
- 2. The University reserves the right to maintain waiting list to fill any future vacant seats, if any.
- 3. The willing candidates have to pay the application fee i.e. ₹2,500 (non-refundable) to be paid online at the time of reporting.
- 4. A merit list will be prepared on the basis of CLAT PG 2025 score (All India Rank) for all candidates who mark their attendance on the day of counselling. Late comers will not be entertained and Physical presence of the candidate is mandatory. No representation in this regard shall be entertained.
- 5. Admission will be provisional and subject to the verification of all the documents and information/facts given in the candidate's application form.
- 6. Provisionally admitted candidates shall be required to deposit the full admission fee of ₹1,23,000/- (Rupees One Lakh Twenty-Three Thousand only) through online mode on the same day. Failure to deposit the fee on the same day shall result in cancellation of admission, and the seat shall be offered to the next eligible candidate. However, in genuine cases, the fee submission deadline may be extended by up to two days, subject to prior approval.
- 7. Any misrepresentation or concealment of facts shall result in cancellation of admission and the candidate may be barred from future admissions.
