Late comers will not be entertained and Physical presence of the candidate is mandatory. No representation in this regard shall be entertained.
- 2. Admission will be provisional and subject to the verification of all the documents and information/facts given in the candidate's application form.
- 3. In case sufficient eligible candidates are not available in any of the aforementioned categories, the vacant seat(s) shall be converted to the All India General Category or any other category, as per the seat conversion policy of the University.
