Be is enacted by the Legislature of the State of Haryana in the Sixty-fifth Year of the Republic of India as follows:—

Short title.

1. This Act may be called the National Law University Haryana (Amendment) Act, 2014.

Amendment of long title of Haryana Act 15 of 2012. 2. In the long title of the National Law University Haryana Act, 2012 (hereinafter called the principal Act), for the words "THE NATIONAL LAW UNIVERSITY HARYANA", the words and signs "DR. B. R. AMBEDKAR NATIONAL LAW UNIVERSITY SONEPAT" shall be substituted.

Amendment of preamble to Haryana Act 15 of 2012.

3. For the existing preamble to the principal Act, the following preamble shall be substituted, namely:—

"to establish and incorporate Dr. B. R. Ambedkar National Law University Sonepat in the State of Haryana for evolving and imparting comprehensive legal education to achieve excellence in all branches of law and its allied disciplines."

Amendment of short title of Haryana Act 15 of 2012. 4. In the short title of the principal Act, for the words "National Law University Haryana", the words and signs "Dr. B. R. Ambedkar National Law University Sonepat" shall be substituted.

7. (1) The National Law University. Haryana (Amendment) Ordinance, Repeal and 2014 (Haryana Ordinance No. 4 of 2014) is hereby repealed.
