#### **About the University**

Dr. B.R. Ambedkar National Law University, established in Sonapat by the State Government of Haryana in 2012 through State Legislature Act No. 15, stands as a premier institution exemplifying India's commitment to justice and constitutional principles. Strategically positioned with excellent connectivity to the NCT of Delhi through air, rail, and road networks, the University maintains distinct advantages over other institutions. The University has eleven specialized research centres, 3 dedicated cells i.e., Alumni Cell, Internship Cell, Equal Opportunity Cell; and a Legal Aid Clinic which foster comprehensive legal education and community service. Dr. B.R. Ambedkar National Law University has established strategic partnerships through MoUs with prestigious institutions such as the V.V. Giri National Labour Institute, the Institute of Constitutional and Parliamentary Studies, and the University of Waikato, New Zealand, among others. #### **Eligibility for admission**

- Must have appeared for CLAT-PG 2025
- Candidates must possess a qualifying LL.B. degree or an equivalent examination with a minimum of *Fifty percent (50%)* marks or its equivalent grade in case of candidates belonging to General and OBC categories and *Forty-Five percent (45%)* marks or its equivalent grade in case of candidates belonging to SC/ST/PWD categories.

*\*In case seats remain vacant after the completion of the standard admission process, the eligibility criteria shall be merit in qualifying examination and it may be notified by the University on their official website.*

### Eligibility Criteria for admission under Foreign National/NRI seats

- Academic record of LL.B. or equivalent degree recognized by the UGC/ Association of Indian Universities with *not less than Fifty percent (50%)* marks or the equivalent grade.
- The candidate selection will be based on an interaction/interview.
- Candidates with TOEFL/ILETS score will be preferred.

### Programme Structure

- **Total Duration:** One Academic Year
- **Semester System:** Two Semesters (Odd: July-December, Even: January-June)
- **Maximum Completion Period:** One year (extension possible with the permission of the Hon'ble Vice-Chancellor and on submission of prescribed fees)

For the academic year 2025-2026, DBRANLU offers four distinct specializations, each meticulously designed to enable LL.M. candidates to explore in-depth areas of law:

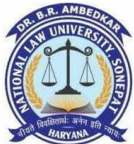
1. Corporate Law
