I am directed to say that National Law University Haryana, Rai, Sonipat, Haryana established by an Act No.15 of 2012 of State Legislature of Haryana as a State University vide notification. Leg/17/2012 dated 26.04.2012 and is empowered to award University vide notification. Leg/17/2012 dated 26.04.2012 and is empowered to award degrees as specified by the UGC under section 22 of the UGC Act 1956 by conducting degrees through its own departments, its constituent colleges and/or through its affiliated courses through its own departments, its constituent colleges and/or through its affiliated colleges in regular mode with the approval of concerned statutory bodies/councils, wherever colleges in regular mode with the approval of concerned statutory bodies/councils, wherever required. The name of the University has been included in the list maintained by the UGC on its website www.ugc.ac.in

The University shall operate only within the territorial jurisdiction allotted to it under its Act and in no case beyond the territory of the State of its location. The University is not allowed to start any off-campus centre beyond the territorial jurisdiction as provided in the Act and under no circumstances beyond the State of its location, as per the Hon'ble Supreme Court Judgment in Prof. Yash Pal vs. State of Chhattisgarh case.

The University may note and adhere to the following the contraction of the contract of the con

- (i) To ensure that no off campus centre(s)/study centre(s) is opened beyond the territorial jurisdiction of the University as stipulated in the Act and in no case beyond the territory of the State.
- (ii) To ensure that no programmes should be offered through franchising arrangement with private institutions.



- In case the university has already started any off-campus study centre and the centre operating through franchises outside the State, it must be dissed immediately.
- No distance education programmes shall be started without the prior approval of (4)
- M.Phil/Ph.D programmes can be conducted as per the provisions of UGC (Minimum (vi) Standards and Procedure for Awards of M.Phil/Ph.D. Degree) Regulations, 2016.
- The University is required to follow all the UGC Regulations notified and available (vii) UGC website www.ugc.ac.in.
