1. All admissions are purely provisional and subject to physical verification of original documents at the time of reporting and resolution of grievance, if any.
2. The shortlisted candidates are required to deposit the full admission fee of **₹1,23,000/- (Rupees One Lakh Twenty-Three Thousand only)** till **11.12.2025, 11:00 AM** through the link <https://forms.eduqfix.com/drbrnational/add>.
