2. The shortlisted candidates are required to deposit the full admission fee **₹84,000/- (Rupees Eighty-Four Thousand only)** till **26.08.2025** through the link <https://forms.eduqfix.com/openentryform/add>. Failure to submit the fee within the stipulated timeframe shall result in cancellation of candidature and forfeiture of the allotted seat, which shall then be offered to the next eligible candidate in order of merit.
3. The Candidates who successfully deposit the fee within the prescribed period shall have to report for **Document Verification (whose DV is pending) on 28.08.2025 (at 12 noon)**. (Application form and checklist of documents is attached herewith).
