Notification -cum-Instruction for Physical Counselling

1. The 4th physical counselling for the admission of B.A.LLB. (Hons.) vacant seats (mentioned below) will be held on **30.10.2024**, Academic Block, Dr. B.R. Ambedkar National Law University, Rai, Sonapat. The interested candidates among the list attached must mark their attendance upto 11:00 AM on the said date.

Late comers shall not be entertained.

Note:- Presence of the Candidate is mandatory.

2. A comprehensive merit list of all the candidates, who shall mark their attendance on the day of physical counselling shall be prepared in order of CLAT-2024 score (All India Rank), which will be applicable for current as well as future vacancies, if any, arises due to left over seats.
3. The admission shall be made strictly on the basis of above mentioned merit list.
4. Applicants who have been offered provisional admission, shall be required to deposit the University fees (i.e. Rs. 1,23,000/-) through online mode, at the time of admission itself.
5. Non-payment of fees on same date & time, the provisional admission shall be stands cancelled & candidate next in merit, will be offered provisional admission.
6. All the applicants must ensure to bring all the following documents in original for verification purpose.
- Proof of payment of Physical Counselling Fee.
 - High School/Secondary School Mark sheet and certificate.
 - Mark sheet and certificate of Intermediate/10+2 examinations.
 - Conduct/ Character certificate from the Institution/University last attended or from Gazetted Officer in case of gap year (Not be more than 6 months old).
 - Migration Certificate from the Institution/University, last attended.
 - Five colour passport size photographs.
 - Score card of CLAT-2024.
 - Admit card of CLAT-2024.

- i) Affidavit for the gap year, if any.
- j) Valid category certificate in case of any type of reservation under categories such as WLREGC-HR / EWS-AI / EWS-HR / OBC-AI / BCB-HR / SC.
- k) OBC (Non-creamy layer), BCB-HR (Non-creamy layer) & EWS category certificate, should be valid for the current financial year. (i.e. 2024-2025). It must be issued on or after 01/04/2024.
- l) Two set of self-attested photocopies of all the above mentioned documents.
- m) Admission form (downloaded from the university website) duly filled-in and signed by the candidates.

Note:- No acknowledgement regarding “applied for” for any document / undertaking, shall not be considered with regard to any original document

General Terms & Conditions of the Provisional Admission

1. The admission will be provisional and subject to the verification of all the information/facts given in the candidate’s application form.
2. The admission of any candidate is liable to be cancelled without giving any further notice forthwith or at any time during the period of the entire course of study, if it is found that the candidate has/had produced fake/forged certificate(s)/document(s) or indulged in any act of misconduct/indiscipline/moral turpitude or has/had concealed any other relevant information at the time of seeking provisional admission. Such a candidate is also liable to be prosecuted under the Law besides being debarred from appearing in any of the Entrance Test of the University in future.
3. Only High School/10th Standard mark sheet/certificate for proof of age and Intermediate/10+2 exam mark sheet/Grade sheet for ascertaining qualifying percentage of marks, shall be considered for B.A. LL.B. (Hons.) Programme.
4. Any attempt by the candidate or anyone else on his/her behalf, to influence and/or pressurize any Authorities/Admission Committee or University directly/indirectly for his/her out of rules admission, shall disqualify the candidate from the admission. Such candidates shall also be liable to be prosecuted as per the provision of Law.
5. The provisional admission of the candidates to the course of study, shall be subject to such rules and regulations as may be framed by the University from time to time.
