Terms and Conditions for allotment of Vita Milk Booth

1. The applicant should be the citizen of India and resident of Haryana. Preference will be given to applicant who will be the resident of same district.
 2. The applicant should be 10th pass from recognized Board.
 3. The applicant age should be between 18-55 years.
 4. Processing fee of Rs. 500/- only will be deposited by the applicant along with the application which will be non-refundable.
 5. The Milk Booth structure cost and other operational expenditure shall be borne by the allottee/holder. The allottee/holder shall be required to enter into an agreement with CEO, of Vita Milk Union, Rohtak and shall deposit a security of Rs. 50000/- with this Milk Union. The security will be non interest bearing. The milk booth allottee/holder shall abide by all terms and conditions of Milk Booth allotment policy.
 6. The responsibility of payment of rent, electricity and water bill etc. shall be that of the allottee/holder and the Vita Milk Union, Rohtak will not be responsible in any manner for the same.
 7. The Milk Booth shall be allotted initially for a period of One year and allotment period shall be extended further on review the performance of work as per Milk Booth allotment policy.
 8. An affidavit shall be given by the allottee/holder that he will not sub-let, transfer, sell, sub-lease, mortgage or dispose of in any other manner, a part or whole of the allotted milk booth to anyone else. In case it is found that milk booth has been sublet, sold, transferred, sublease or mortgaged to any party by the allottee/holder, the allotment will be cancelled immediately.
 9. The milk booth will have to be made functional by the allottee within a period of one month from the completion of structure and installation of electric meter; otherwise the site of milk booth will be cancelled and allotted to the next in waiting list.
 10. The milk booth allottee/holder will not sell any dairy product other than Vita milk and milk products & other products which are not permitted by Vita Milk Union, Rohtak.
